

REGULAR MEETING OF THE MILTON TOWNSHIP BOARD

April 1, 2008

A Regular Meeting of the Milton Township Board was held in the Board Room of the Milton Town Hall, 1492 N. Main Street, Wheaton, Illinois, on Tuesday, April 1, 2008, for the audit of town bills followed immediately by a business meeting.

Board Members Present: Supervisor O. Chris Heidorn - Clerk A. Arlene DeMotte - Trustees James D. Flickinger, Sal Falbo, Robert L. Larsen, and Leonard Sanchez. Board Members Absent: None. Other Elected Officials Present: Assessor Robert Earl and Highway Commissioner Gary Muchfeldt. Also Present: Kathleen Gillespie and son Mike Hisson, Marie Jensen, Chris Edwards, and Mark Kmiecik.

The business meeting was called to order by Chairman Heidorn at 7:30 p.m. Mike Hisson led the Pledge of Allegiance. A quorum was present and acting, and due notice had been mailed.

Trustee Falbo moved, seconded by Trustee Sanchez, to approve the agenda as presented. The motion passed by voice vote.

Trustee Flickinger moved, seconded by Trustee Falbo, that the minutes of the Regular Meeting on March 11, 2008, and the Special Meeting on March 25, 2008, be approved as submitted. The motion passed by voice vote.

Having concluded their audit of the Township bills in the earlier segment of the meeting, Trustee Falbo moved, seconded by Trustee Flickinger, that the bills having been audited be paid and charged to the proper accounts, and the certificates of accounts be filed by the Clerk for inspection by the inhabitants of the Township. The motion passed on the following roll-call vote: 5 Ayes: Trustees Flickinger, Falbo, Larsen, and Sanchez, and Chairman Heidorn. 0 Nays.

Public Forum - Kathleen Gillespie thanked the Township for doing a good job of clearing the unincorporated township roads of snow.

Highway Commissioner Muchfeldt presented his Annual Report to the Board. He highlighted the report, and reported on the cleanup after the tornado and the parking problem created by the new church on Swift Road. "No Parking" ordinances have been implemented and signs posted along Swift Road.

Chairman's Report:

- Chairman Heidorn presented the Supervisor's Annual Report to the Board. There were no questions.
- Miscellaneous - A Certificate of Appreciation was received from the Northern Illinois Food Bank. The Board authorized Chairman Heidorn to write our legislators encouraging a "yes" vote on non-mandatory pending legislation which would provide a pay increase for township cemetery trustees from up to \$500 per year to up to \$1,000 per year.

Clerk DeMotte reminded the Board that the Annual Meeting will be held next week, April 8th, at the Glen Ellyn Civic Center.

There were no reports from the S.A.L.T. Committee or the Committee on Youth.

Cemeteries Authority - Chairman Heidorn reported that Spring cleanup has begun.

Unfinished Business: None.

New Business: None.

Trustee Falbo and the Board briefly discussed pending legislation regarding future township annual meetings.

There being no further business to come before the Board, Trustee Flickinger moved, seconded by Trustee Sanchez, that the meeting stand adjourned. The motion carried by voice vote, and the meeting adjourned at 8:05 p.m.
