MILTON TOWNSHIP

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2007, collectable in 2008. **Mosquito Abatement District Fund**

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of ~~Fifty-Six Thousand Five Hundred and no/100 Dollars (\$56,592.00)~~ **CERTIFICATION OF COMPLIANCE WITH PA** is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

I, O. Chris Heidorn, the presiding officer of Milton Township do hereby certify that a copy of which is attached hereto, was adopted pursuant to, and in compliance with or inapplicability of the provisions of Section 4 through 7 of "Truth in Taxation Act." Public Act 82-102 (IRS), Ch 120, Section 8-1-89.1. That the amount levied for each object and purpose shall be as itemized on the following page.

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December a duly certified copy of this ordinance.
