TAX LEVY ORDINANCE

MILTON TOWNSHIP

ORDINANCE NO. O-08-5

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2008, collectable in 2009.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **One Million Eight Hundred Ninety Four Thousand Nine Hundred Thirteen and 37/100** Dollars (**\$1,894,913.37**) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund and General Assistance Fund

for the year 2008.

SECTION 2: That the amount levied for each object and purpose shall be as follows:


