An ordinance levying taxes for the Special Police District for Milton Township, DuPage County, Illinois, for the tax year 2009, collectable in 2010.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **Two Hundred Fourteen Thousand Three Hundred Forty and 91/100** Dollars (**\$214,340.91**) is hereby levied upon all property subject to taxation within the Milton Township Special Police District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

for the year 2009.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.

ADOPTED the 8th day of December, 2009, pursuant to a roll call vote of the Township Board of Milton Township, DuPAGE County, Illinois.


