An ordinance levying taxes for the Mosquito Abatement District for Milton Township, DuPage County, Illinois, for the tax year 2010, collectable in 2011.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **Eighty Two Thousand Five Hundred Seventeen and 00/100 Dollars (\$82,517.00)** is hereby levied upon all property subject to taxation within the Milton Township Mosquito Abatement District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

for the year 2010.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.

ADOPTED the 14th day of December, 2010, pursuant to a roll call vote of the Township Board of Milton Township, DuPAGE County, Illinois.




