ORDINANCE NO. HW O-13-1

**AN ORDINANCE RESTATING AND ADOPTING REGULATIONS
SET FORTH IN ORDINANCE NO. 0-97-14
CONCERNING ROADS UNDER THE JURISDICTION
OF MILTON TOWNSHIP**

WHEREAS, in 2005, the Milton Township Highway Commissioner adopted Ordinance No. HW O-5-4 which amended parking restriction for roads under his jurisdiction; and

WHEREAS, an unintended result of the adoption of Ordinance HW O-05-4 is a perception that the parking restrictions set forth in Ordinance No. 0-97-14 have been superceded; and

WHEREAS, in response to this perception, the Township Highway Commissioner restates and adopts the parking restrictions set forth in Ordinance No. O-97-14, except to the extent any item set forth therein is in conflict with parking regulations set forth in Ordinance HW O-05-4, so that the two ordinances may be read in concert.

NOW THEREFORE, BE IT ORDAINED BY THE HIGHWAY COMMISSIONER OF MILTON TOWNSHIP, AS FOLLOWS:

Section 1. The foregoing recitals are hereby incorporated by reference as if fully set forth herein.

Section 2. Ordinance O-97-14, attached hereto as Exhibit "A," is hereby adopted and restated, except to the extend it is in conflict with provisions set forth in Ordinance O-05-4.

Section 3. All provisions of this Ordinance shall be in full force and effect from and after the date of adoption of this Ordinance, and publication as set forth by law.


