

TAX LEVY ORDINANCE

MILTON TOWNSHIP ROAD DISTRICT

ORDINANCE NO. O-13-4

An ordinance levying taxes for all road purposes for the Milton Township Road District, DuPage County, Illinois, for the tax year 2013, collectable in 2014.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Milton Township Road District on December 9, 2008, does hereby determine and declare that the sum of **Three Million Two Hundred Fifty Five Thousand Six Hundred Forty Three and 08/100 Dollars (\$3,255,643.08)** is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

The General Road Fund

for the fiscal year 2015.

SECTION 2: That the amount levied for each object and purpose shall be as follows:


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised for taxation for road purposes for the Milton Township Road District.
