PUBLIC HEARINGS

Public Hearings on the FY 2011-2012 budget and appropriations for the Road District, and the Town, General Assistance, Special Police, and the Mosquito Abatement District Funds scheduled to begin at 7:15 p.m. were held at the Wheaton Park District Community Center, 1777 S. Blanchard Rd., Wheaton, Illinois on Tuesday, March 29, 2011.

Board Members Present: Supervisor O. Chris Heidorn- Clerk Gail P. Hinkle-Trustees Sal Falbo, Christopher Edwards and Marie Jensen. Absent: Trustee James Flickinger. Other Elected Officials Present: None. Also present: Ralph G. Hinkle, Chris Levan and Jack Boepple.

The Public Hearing on the Road District was called to order by Chairman Heidorn at 7:20 p.m.

The Legal Notices for the Public Hearings on the Road District and the Town Funds were published in the *Daily Herald* on February 16, 2011.

The Tentative Budget for FY 2011-2012 for the Road District and the Town Funds were accepted by the Board on February 8, 2011.

Chairman Heidorn moved, seconded by Trustee Jensen, to amend the Road District Budget for the fiscal year 2011-2012, as presented on the document entitled Milton Township Road District, Ordinance No. 0-11-1, *Tentative as amended*, totaling \$1,909,016. The motion passed by voice vote. (All Ayes).

Trustee Falbo moved, seconded by Chairman Heidorn to adopt the Milton Township Road District Budget & Appropriation Ordinance as tentative as amended. The motion passed on the following roll-call vote: 4 Ayes: Trustees Falbo, Edwards, Jensen and Chairman Heidorn. 1 Absent for Vote: Trustee Flickinger.

Chairman Heidorn moved, seconded by Trustee Edwards, to amend the 2011-2012 Tentative Town Budgets as presented on the document entitled Milton Township Budget & Appropriation Ordinance No. 0-11-2, *Tentative as amended*, totaling \$2,663,709. The motion passed by voice vote. (All Ayes).

Trustee Jensen moved, seconded by Trustee Edwards to approve the Milton Township Budget & Appropriation Ordinance as tentative as amended. The motion passed on the following roll-call vote: 4 Ayes: Trustees Falbo, Edwards, Jensen and Chairman Heidorn. 1 Absent Vote: Trustee Flickinger.

The appropriations for the Town Funds are:

- General Town Fund \$2,104,417
- General Assistance Fund \$265,469
- Special Police District Fund \$221,823
- Mosquito Abatement District \$82,000

There being no further comments or questions on the Town Budgets, Chairman Heidorn closed the Public Hearing on the Town Budgets.
