**TAX LEVY ORDINANCE**  
**MILTON TOWNSHIP**  
**Corporate and Public (General) Assistance**  
ORDINANCE NO. O-12-5

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2012, collectable in 2013.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of One Million Nine Hundred Twenty Seven Thousand Four Hundred Ninety Two and 31/100 Dollars (\$1,927,492.31) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

for the fiscal year 2014.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
