# TAX LEVY ORDINANCE

#### MILTON TOWNSHIP HIGHWAY DEPARTMENT

# ORDINANCE NO. O-14-4

An ordinance levying taxes for all road purposes for the Milton Township Highway Department, DuPage County, Illinois, for the tax year 2014, collectable in 2015.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Milton Township Highway Department on December 9, 2014, does hereby determine and declare that the sum of Three Million Three Hundred Seventy Thousand Four Hundred Eighty and 00/100 Dollars (\$3,370,480.00) is hereby levied upon all property subject to taxation within the Highway Department as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Highway DepartmentRoad District as required by statute or voted by the people in accordance with the law, for such purposes as:
