

TAX LEVY ORDINANCE

**MILTON TOWNSHIP
Corporate and Public (General) Assistance**

ORDINANCE NO. O-14-7

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2013, collectable in 2014.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of Two Million Twenty Six Thousand Two Hundred Forty and 00/100 Dollars (\$2,026,240.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund and General Assistance Fund

for the fiscal year 2015.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




