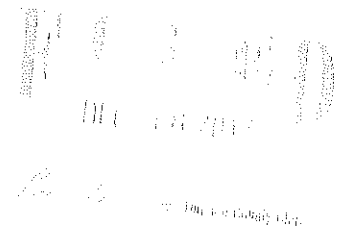


**TAX LEVY ORDINANCE**  
**MILTON TOWNSHIP**  
**Corporate and Public (General) Assistance**

**ORDINANCE NO. O-17-7**



An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **Two Million One Hundred Eighty Six Thousand and 00/100** Dollars (\$2,186,000.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

**General Town Fund and General Assistance Fund**

for the fiscal year 2019.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.





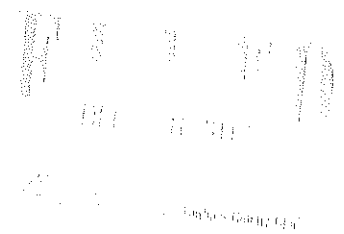

An ordinance levying taxes for the Mosquito Abatement District for Milton Township, DuPage County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of Seventy One Thousand Five Hundred Eighty Nine and 00/100 Dollars (\$71,589.00) is hereby levied upon all property subject to taxation within the Milton Township Mosquito Abatement District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

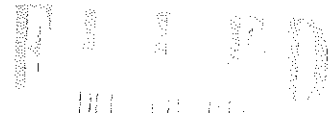




