## ORDINANCE NO. O-17-6

An ordinance levying taxes for the Mosquito Abatement District for Milton Township, DuPage County, Illinois, for the tax year 2017, collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of <u>Seventy One Thousand Five Hundred Eighty Nine and 00/100</u> Dollars (\$71,589.00) is hereby levied upon all property subject to taxation within the Milton Township Mosquito Abatement District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
