An ordinance levying taxes for the Special Police District for Milton Township, DuPage County, Illinois, for the tax year 2013, collectable in 2014.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of <u>Two Hundred Sixty Eight Thousand One Hundred Four and 38/100</u> Dollars (\$268,104.38) is hereby levied upon all property subject to taxation within the Milton Township Special Police District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
