An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **Two Million Two Hundred Ninety Six Thousand Four Hundred Forty and 00/100** Dollars (\$2,296,440.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund and **General Assistance Fund**

for the fiscal year 2021.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December a duly certified copy of this ordinance.


SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.


SECTION 6: The Board of Trustees, while acknowledging its responsibility to the taxpayers of Milton Township to tax no more than is necessary for the proper administration of Township business, understands the complexities and pitfalls of the Property Tax Extension Limitation Law (PTELL). In order to serve the interests of the taxpayers and yet protect the taxing authority of the Township it is the intent of the Board of Trustees to abate \$200,000.00 from the Public (General) Assistance levy in January, 2020.


