TAX LEVY ORDINANCE

MILTON TOWNSHIP HIGHWAY DEPARTMENT

ORDINANCE NO. O-19-3

An ordinance levying taxes for all road purposes for the Milton Township Highway Department, DuPage County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Milton Township Highway Department on December 11, 2019, does hereby determine and declare that the sum of **Three Million Eight Hundred Twenty Thousand Eight Hundred Eighty Five and 00/100 Dollars (\$3,820,885.00)** is hereby levied upon all property subject to taxation within the Highway Department as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Highway Department Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund
IMRF Fund

Insurance Fund
Permanent Road Fund

Social Security Fund

for the fiscal year 2020.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 6: That this ordinance shall be in full force and effect after its adoption as provided by law.
