#### ORDINANCE NO. O-19-5

An ordinance levying taxes for the Mosquito Abatement District for Milton Township, DuPage County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:
