

## TAX LEVY ORDINANCE

## MILTON TOWNSHIP HIGHWAY DEPARTMENT

#### ORDINANCE NO. O-20-2

An ordinance levying taxes for all road purposes for the Milton Township Highway Department, DuPage County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Milton Township Highway Department on December 8, 2020, does hereby determine and declare that the sum of <u>Three Million Eight Hundred Seventy Five Thousand Five</u> <u>Hundred and 00/100 Dollars (\$3,875,500.00</u>) is hereby levied upon all property subject to taxation within the Highway Department as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Highway Department Road District as required by statute or voted by the people in accordance with the law, for such purposes as:



SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised for taxation for road purposes for the Milton Township Highway Department.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption as provided by law.

ADOPTED this 8<sup>th</sup> day of December, 2020, pursuant to a roll call vote of the Township Board of Milton Township, DuPAGE County, Illinois.
