ORDINANCE NO. O-20-4

An ordinance levying taxes for the Consolidated Milton Township-Glen Ellyn Mosquito Abatement District for Milton Township, DuPage County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **Two Hundred Thirty Six Thousand Seven Hundred and 00/100 Dollars (\$236,700.00)** is hereby levied upon all property subject to taxation within the Milton Township Mosquito Abatement District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

Mosquito Abatement District Fund

for the fiscal year 2021.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
