ORDINANCE NO. O-21-5

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of <u>Four Hundred Twenty-Nine Thousand Eight Hundred Fifty</u> Dollars (\$429,850) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
