

**RESOLUTION NO. R-21-13**

**A RESOLUTION AUTHORIZING AN AGREEMENT  
WITH THE TOWNSHIP ROAD DISTRICT  
FOR EMPLOYEE COST SHARING**

**WHEREAS**, Milton Township (“Township”) is a body corporate and politic existing and operating in the State of Illinois pursuant to the Illinois Township Code, 60 ILCS 1.01 *et seq.*; and

**WHEREAS**, Milton Township Road District (“Road District”) is a body corporate existing and operating in the State of Illinois pursuant to the Illinois Township Code, 60 ILCS 1.01, *et seq.*, and the Illinois Highway Code, 605 ILCS 5/6-101 *et seq.*; and

**WHEREAS**, the Road District requires the assistance of certain Township administrative staff to ensure the proper accounting of, deposit, and return of monies paid to the Road District for work undertaken within the jurisdiction of the Road District and for certain other administrative duties; and

**WHEREAS**, the Township has a staff member available to assist in the duties required by the Road District; and

**WHEREAS**, both the Township and the Road District believe it is in the best interests of the residents of Milton Township that they enter into an agreement which will allow for cost sharing for a designated employee who will provide services to both the Township and the Road District, on the terms set forth in this Resolution.

**NOW, THEREFORE BE IT RESOLVED** by the Supervisor and Board of Trustees, Milton Township, DuPage County, Illinois, and by signature of the Milton Township Highway Commissioner agreed to, as follows:

**SECTION ONE:** That the recitals set forth above are incorporated herein and made a part hereof.

**SECTION TWO:** That the Township shall assign an employee to work directly with the Road District on the accounting of monies deposited with the Township and on such other duties as assigned by the Road District.

**SECTION THREE:** That the employee so assigned shall be at all times an employee of the Township, subject to its rules, regulations and authority.

**SECTION FOUR:** For purposes of the work undertaken for the Road District, the employee shall serve under the supervision of the Highway Commissioner or his designee.


**SECTION FIVE:** For said employee, the Road District shall include within its annual budget the sum of \$20,000.00 which shall be paid over to the Township at the start of each budget year, with the payment this year in the amount of \$13,333.33, to pay for services rendered from August 2021 through the end of the current budget year. Should the Township cease to provide an employee pursuant to this agreement, the obligation of the Road District to pay for such an employee shall cease and any monies paid at the commencement of any budget year shall be reimbursed to the Road District on a prorata basis.

**SECTION SIX:** That all resolutions or motions in conflict with this Resolution are hereby repealed to the extent of such conflict.

**SECTION SEVEN:** That this resolution shall take effect immediately upon passage.


