A RESOLUTION SETTING COMPENSATION FOR ELECTED OFFICIALS FOR THE FOUR-YEAR TERM BEGINNING MAY 2021 AND THE ASSESSOR'S TERM BEGINNING JANUARY 2022

WHEREAS, the Township Board of Milton Township is required by law, no later than 180 days prior to the next term of office, to fix the compensation for the Township Elected Officers whose terms begin May 2021 and end May 2026, and the Assessor's term beginning January 1, 2022; and ending December 31, 2026, and;

WHEREAS, the said Board has diligently and carefully reviewed the functions and responsibilities of the elected officials' offices to be filled at the Consolidated Election to be held in April, 2021;

NOW, THEREFORE BE IT RESOLVED by the Township Board of Milton Township that the compensation for the Milton Township Elected Officers for the four-year terms, beginning May 2021, and the Assessor's term beginning on January 1, 2022, shall be annually as follows:

BE IT FURTHER RESOLVED that the Supervisor shall be paid, as provided for by statute, an additional \$1,000 annually as Treasurer of the Milton Township Road District Funds;

BE IT FURTHER RESOLVED that the Supervisor, Assessor, and Highway Commissioner are eligible for Township medical, dental, and life insurance, and may participate in such plans, under the same terms as the Township employees;

BE IT FURTHER RESOLVED that the Supervisor, Assessor and Highway Commissioner may participate in the Illinois Municipal Retirement Fund (IMRF);

BE IT FURTHER RESOLVED that the Supervisor, Clerk, Highway Commissioner, and four Trustees begin their new term of office in May 2021, and this Compensation Resolution for these offices is effective as of the new term of office beginning in May 2021;

BE IT FURTHER RESOLVED that the Assessor begins his new term of office on January 1, 2022, and this Compensation Resolution for the office of Assessor is effective as of January 1, 2022.
