MILTON TOWNSHIP ROAD DISTRICT

ORDINANCE NO. 0-07-6

An ordinance levying taxes for all road purposes for the Milton Township Road District, DuPage County, Clark Illinois, for the tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Milton Township Road District on November 14, 2006, does hereby determine and declare that the sum of Two Million Seven Hundred Eighty Thousand Three Hundred Sixty-Eight and no/100 Dollars (\$2,780,368.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

The General Road Fund

for the year 2007.

SECTION 2: That the amount levied for each object and purpose shall be as itemized on the following pages. The AMOUNT TO BE LEVIED was determined by the Highway Commissioner of the Milton Township Road District.

SECTION 3: That the Town Clerk shall file with the County Clerk of said County of DuPage, on or before the last Tuesday of December a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised for taxation for road purposes for the <u>Milton Township</u> Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption as provided by law.

ADOPTED this 11th day of <u>December</u>, 2007, pursuant to a roll call vote of the Township Board of <u>Milton</u> <u>Township</u>, DuPAGE County, Illinois.


