TAX LEVY ORDINANCE

ORDINANCE NO. 0-07-7

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of **One Million Seven Hundred Eight-Five Thousand Three Hundred Twenty-Four and no/100 Dollars (\$1,785,324.00)** is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund and General Assistance Fund

for the year 2007.

SECTION 2: That the amount levied for each object and purpose shall be as itemized on the following pages.

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.

ADOPTED the 11th day of December, 2007, pursuant to a roll call vote of the Township Board of Milton Township, DuPAGE County, Illinois.


