ORDINANCE NO. 0-10- 5

An ordinance levying taxes for all road purposes for the Milton Township Road District, DuPage County Clark Illinois, for the tax year 2010, collectable in 2011.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Milton Township Road District on December 14, 2010, does hereby determine and declare that the sum of <u>Three Million Nine Thousand Four Hundred Sixty Eight and 16/100 Dollars (\$3,009,468.16)</u> is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
