## How To Spot A Fraudulent Website

Most of the almost two billion websites on the internet are legitimate. Some sites, however, are phony and are run by scammers trying to steal personal information and money from their victims. Here are several ways to help spot a fraudulent site:

- <u>Check the web address (URL name</u>): Scammers create websites with names that are similar to those of their legitimate counterparts. The goal is to trick victims into believing they are dealing with the actual site. The difference in the names of the real and phony sites can be very subtle. For example, you may think you're visiting <u>amazon.com</u>, but you're actually visiting <u>amazom.com</u>. Or, you may think you're visiting <u>microsoft.com</u>, but you're actually visiting <u>rnicrosoft.com</u>. (Notice the spelling of the URL names "a m a z o <u>m</u>" and "<u>r n l c r o s o f t.</u>") Once you've accessed a fraudulent site, you are vulnerable to identity theft and the loss of money from your accounts.
- 2. Look for the padlock icon and "https" in the address bar: These signify the information transmitted between the user and the website is encrypted and the site is secure. Secure sites are issued a certificate to confirm that users are protected. You can verify that a certificate is valid and view details of the certificate on a PC by following these steps: a) double-click on the padlock in the address bar, b) click on "Connection is secure," and c) click on "Certificate is valid." Some sites that are not secure contain a padlock icon in the address bar with a strike through it or a message stating "Not secure." Do not provide personal or financial information on sites that are not secure.
- 3. <u>Verify the website's privacy and return policies</u>: Many fraudulent websites do not contain customer return and privacy policies. If the policies are included, they are often brief and poorly written. Before completing an online transaction, be sure to review the site's policies to make sure they meet with your approval. Consider, for example, if you can return or exchange an item without paying a penalty. Avoid conducting business on sites without acceptable policies.
- 4. <u>Check for spelling and grammatical errors</u>: If a website contains spelling and grammatical errors, it may be operated by scammers in another country with a poor command of the English language. Legitimate sites are designed by trained professionals and are usually error-free. Avoid entering personal or financial information on sites with these errors.

## Steps to take if you're the victim of an online scam:

- If you made a purchase on a fraudulent site with a credit or debit card, report it to the issuing bank. They will freeze your account and give you a new card.
- If you provided credit card or personal information on a fraudulent site, report it to one of the three credit bureaus: 1) Experian (*experian.com*); 2) Equifax (*equifax.com*); or 3) TransUnion (*transunion.com*). The credit bureau to whom you report the incident will notify the other two. All three bureaus will freeze your account to prevent fraudsters from taking out loans or opening new accounts in your name.
- File a report with the Internet Crime Complaint Center (IC3) at *ic3.gov*. The IC3 refers complaints of suspected internet criminal activity to the FBI for investigation.
- File a report with your local police department.

A Note From The Assessor's Office

## Hello from the Milton Township Assessor's Office!

We welcome the opportunity to build relationships with our community, especially our seniors. The last two years have been difficult for all of us to meet, gather and communicate

in a meaningful way with one another. To that end, our office has taken special precautions to provide a safe, healthy environment for everyone we serve. We petitioned for PPE monies to build a new handicap accessible front counter and created a contactless, streamlined entryway to enhance public interactions. We also used PPE money to improve air quality and thoroughly sanitize our office. All of this was done at no cost to taxpayers and is to the benefit of everyone we have contact with.

With regards to assessing (valuing township property) ... We closed our books on the 2021 Assessment Year and 2022 has begun. During the years between the General Re-Assessment Year we review all new construction, additions and any potential neighborhoods which demonstrate a market lag. According to Illinois State Statute, the General Re-Assessment Year requires townships (outside of Cook) to review all township properties every four years. Milton Township has roughly 41,000 properties to view and evaluate. The next General Re-Assessment Year is 2023 so we will be very busy! In the interim, most township property owners will only receive the township-wide equalization factor issued by the DuPage County Supervisor of Assessments Office. For 2020 and 2021, our factor was one of the lowest of all 9 townships in DuPage County! This is related to how closely we assess all township properties to the statutory level of 33 1/3 and it demonstrates how equitable our assessment practice is. Ultimately, this saves taxpayers money! Please visit our website at www.miltonassessor.com to learn more about the assessment process. Our website features a handy blue property search button to view all township properties. Our homepage reflects relevant updates regarding procedure, deadlines and exemption information. Check it out!

Speaking of Exemptions... The DuPage County Supervisor of Assessments Office (SOA) is responsible for administering, reviewing and determining eligibility for almost all exemptions. As a courtesy to you, our office assists township residents with the completion of necessary paperwork for the Senior Homestead Exemption and the Senior Freeze. Once completed, both are forwarded to the SOA for eligibility verification. Each exemption provided has different qualifications, savings and deadlines.

The Senior Homestead Exemption is the main senior exemption, as it is provided to everyone 65 years of age. It removes 5000 assessed dollars from the assessed value of your property, which roughly equates to \$300-\$400 savings on your property tax bill. To qualify for the Senior Homestead Exemption, you must turn 65 the year you apply and show proof of age and proof of ownership. The best feature of this exemption is that you do not need to complete yearly documentation once you have applied and deemed eligible by the SOA. This exemption maintains itself unless you move from your property!

The Senior Freeze Exemption is an age and income-based exemption which freezes the taxable level of assessment of your property. It does not freeze your taxes. Since income changes, you must apply for the senior freeze every year. Before applying for the Senior Freeze Exemption, you will need to apply and be approved for the Senior Homestead Exemption. To qualify for the Senior Freeze Exemption, you need to be 65 of age as of the assessment year, own and occupy your residence for two consecutive January 1<sup>st</sup>s and have a total household income of \$65,000 or less (as of the prior year). If you believe you qualify for this exemption, you will need to provide a copy of your federal income taxes (1040 or 1040A) from the prior year, as well as proof of age (Illinois driver's license reflecting current address and age). If you have applied and were approved for the Senior Freeze in the past, you will receive the application from the SOA in the mail. The soft deadline for the Senior Freeze is October 1<sup>st</sup> every year.

\*Please note, Governor Pritzker signed legislation to rollover all Senior Freeze exemptions for 2020 and 2021, so there is no need to re-apply if you were approved in 2019 or 2020. Since the Supervisor of Assessments Office administers exemption paperwork, and the status of the Senior Freeze Exemption is determined by the legislature, we do not yet know if a rollover will occur for 2022. This means there will not be any 2022 applications until we receive further information. (Due to legislative delays, our office did not receive the 2021 application until July of 2021!) Please check our website at www.miltonassessor.com for updates. Once we receive the 2022 application we will post it on our home page under "Latest News". Or, call the DuPage County Supervisor of Assessment's Office directly at (630) 407-5858 with any questions regarding the Senior Freeze application or deadline.
