
TAX LEVY ORDINANCE



MILTON TOWNSHIP Mosquito Abatement District

ORDINANCE NO. O-22-06

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum of <u>Two Hundred Sixty Five Thousand and Three</u> 34/100Dollars (\$265,003.34) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
