ORDINANCE NO. 0-22-07 - Corporate & Public (General) Assistance

ORDINANCE NO. 0-22-08 - Community Mental Fund 708 Board

An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum(s) of Two Million Five Hundred Thirty Two Thousand Nine Hundred Nine and 30/100 + CMHB Eight Hundred Forty Eight Thousand Ninty Seven and 30/100 Dollars (\$2,532,909 + \$848,097.30 CMHB Tax) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund, General Assistance Fund Community & Mental Health Fund

for the fiscal year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

<b><u>General Town Fund:</u></b>	
REF: General Corporate Tax (60 ILCS 1/235-10)	\$ <u>2,332,909.30</u>
<b><u>Mental Health Facilities Fund:</u></b>	
REF: Community Mental Health Act (405 ILCS 20/4)	\$ <u>848,097.30</u>
<b><u>General Assistance Fund</u></b>	
REF: General Assistance Tax (60 ILCS 1/235-20)	\$ <u>200,000.00</u>

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of DuPage, on or before the last Tuesday of December a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.




SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.


**CERTIFICATION OF TAX LEVY ORDINANCE
