

SCAM REPORT

Package Delivery Scam



How it works: You receive an email or text message from a delivery driver looking for your residence. The driver states he works for UPS® (United Parcel Service), FedEx® Corporation, or the USPS (United States Postal Service) and has a parcel for you, but there are "problems with your shipping address." The message includes a tracking number and the delivery company's logo and graphics, and appears to be authentic. You are instructed to call the driver on his cell phone to re-confirm the delivery and provide directions.

If you call the number, you are asked to verify your name and address. The driver asks for your credit card information to cover a small delivery and handling fee. If you comply with the request and furnish the information, your identity has been stolen. Money will be drained from your account and fraudulent purchases will be charged to your credit card. No parcel will be delivered to you.

If you tell the driver you did not order anything for delivery, you are advised the package is a gift from a relative or friend, so you would not have expected it. The driver is courteous and patient and has a professional demeanor throughout the conversation, making it difficult for you to spot this as a scam.

Instead of calling the driver on his cell phone, you may be asked to click on a link or open an attachment in the message to re-confirm the delivery and provide directions. If you follow these instructions, malicious software is installed on your device, and fraudsters will steal your personal and financial information.

How to protect yourself

- Keep a record of all packages you are expecting, when they are scheduled for delivery, from what companies they were ordered, and their tracking numbers. When you place an online order for delivery, you will receive a tracking number when the vendor confirms the order. Tracking numbers allow you to monitor the movement of in-transit parcels you are expecting and help verify what a carrier's agent tells you about a pending delivery.
- Never provide personal or financial information to unsolicited callers. Legitimate delivery carriers do not charge to "redeliver" a parcel and will not ask for this information.
- Do not click on links or open attachments in unsolicited emails or text messages. If you're not sure whether a message from a delivery carrier is authentic, contact the carrier's customer service department for confirmation. Use the legitimate website address or telephone number listed below, not one that was given to you by someone else.



- Before providing any information online, be sure the carrier's URL in your browser's address bar is correct and that it is preceded by a "padlock" icon. The icon signifies the website is secure and the data are encrypted.
- Look for the following signs of bogus carrier websites: misspelled email or website addresses (e.g., fedx.com, fed-ex.com, usps.gov), spelling and grammatical errors, and the excessive use of capital letters and exclamation points.
- Do not conduct online transactions if you are in a public Wi-Fi environment (e.g., library, airport, coffee shop). Individuals nearby may have access to the information on your device.
- If you are a victim of this scam, report it to the delivery carrier and your local police department.

July Speaker - Keely Bufffo RN Topic: North Western Medicine Mobile Stroke Unit

The Milton Township S.A.L.T. Council was very appreciative to have the Northwestern Medicine Mobile Stoke Unit present at our July 2023 monthly meeting. Our community is blessed to have the only unit of its kind in Illinois serving us with such an important and critical service.

Kelly Buffo RN, Manager of the Mobile Stroke Unit presented at our July meeting along with the entire unit team that is dispatched to a call for assistance.

Why community outreach for stroke?

Manager Buffo stated that 1 in 6 deaths from cardiovascular disease were due to stroke with 795,000 people experiencing a new or recurrent stroke each year.

She stated that it is vitally important that the public be educated regarding both stroke awareness and stroke preparedness.

Stroke awareness= the ability to recognize the signs and symptoms of stroke Stroke preparedness= coupling the knowledge of stroke signs and symptoms with the behavior of calling 911.

WHAT IS THE MOBILE STROKE UNIT (MSU)? *Medic 34

- · Ambulance with an embedded CT scanner
- · Point of care lab testing
- · Wireless connection to immediately transmit the CT image to the hospital
- · Telemedicine connection to the CDH neurologist
- · Allows the CDH Stroke Team to initiate treatment at the scene

Meet the Crew: Driver (FF/EMT), CT Technologist, Critical Care Paramedic, Critical Care Neuro Nurse, Physicians on call Neurologist, and the Neuro-Radiologist.

 Caused by a blockage in the blood vessels to the brain


Hemorrhagic (Bleeding) 13%

September Speaker - Julio A. Leal **Topic: What is RTA?**

RTA stands for Regional Transportation Authority. The RTA website explains that "[RTA] is government agency created by the State of Illinois to coordinate the Chicago region's transit system, oversee its financing with transparency and accountability, and plan for a future with adequate, accessible, and equitable public transportation for the six counties of Northeastern Illinois". The RTA believes in promoting travel independence and empowering customers with mobility options. The RTA's Mobility Management Program helps customers with disabilities and older adults' access accessible transit in the RTA region.

The RTA services include:

- **Group Transit Orientation presentations**
- Provide transit information and RTA program assistance at outreach events and resource
- One-on-one Travel Training to individuals in their communities

The RTA offers in-person and virtual presentations Topics include:

RTA Program – RTA allows a person to ride on the CTA, the Metra, and/or the fixed Pace bus route. We are happy to help sign you up for a Senior Ride Free Permit or the RTA card for those with Disabilities Reduced Fare Program.

Other Milton Transportation Services:

Ride DuPage - The Milton Township Ride DuPage program serves unincorporated Wheaton and Glen Ellyn. The incorporated residents of Milton Township can apply to other municipalities, such as the City of Wheaton or the Village of Glen Ellyn. We also service the villages of Carol Stream and Glen Ellyn. Residents must be 65 years of age and disabled persons to qualify. Ride DuPage is a curb-to-curb transportation service within DuPage County. It can be utilized for medical appointments, volunteer work, shopping, social visits, etc. Participants must register for the program before making a reservation.
