## MILTON TOWNSHIP ANNUAL MEETING

## April 12, 2022

The Annual Meeting of Milton Township, Count of DuPage was held at the Wheaton Park District Community Center, Wheaton, Illinois, on April 12, 2022 at 7:00PM. There were guests and public at the meeting. There were seven township officials in attendance: Supervisor, John Monino, Assessor, Chris LeVan, Clerk, Yadav Nathwani, and Trustees, Dan Milinko, Jeff Castle, Joe Soto, and Drew Ellis.

That meeting was called to order by Yadav Nathwani at 7:00 P.M. followed by the Pledge of Allegiance led by Mark Senak.

Clerk Nathwani introduced the elected officials.

The first order of business was a call by the Clerk for nominations of a Moderator for the Annual Meeting. Lori Carlson of Glen Ellyn nominated Pat Bond to serve as moderator. Marty Keller of Wheaton moved the nomination of Pat Bond, and Grant Eckhoff of Wheaton seconded the nomination. No other nominations were presented and the nominations were closed on the motion of Paula Smith of Wheaton, seconded by Chuck Smith of Wheaton. Pat Bond was unanimously elected Moderator by voice vote.

Clerk Nathwani administered the oath of Moderator to Mr. Pat Bond who then conducted the meeting.

Pat Bond welcomed everyone to the 173<sup>rd</sup> Annual Township Meeting. Mr. Bond introduced himself and gave a brief history on township government. He also introduced the Parliamentarian Robert Margetts and Sergeant-at-arms Greg Moffett for tonight's meeting.

Mr. Bond stated that as required by law, the township Board must approve the Agenda as presented. The township board approved the agenda earlier in the year. Copies of the Agenda and the meeting minutes of April 13, 2021 were made available for all attendees of this meeting.

Annette Corrigan of Wheaton, seconded by Robert Margetts of Glen Ellyn, to dispense with the reading of the minutes and to approve the Minutes of April 13, 2021. The motion carried by voice vote.

Mr. Bond announced the dispensing of the reading of the Supervisor's Annual Statement that was available to everyone at the meeting.

Mr. Monino announced, as the Supervisor of Milton Township his accomplishment in his first year. He was happy to announce an expansion of Township services, including but not limited to, a food truck, recycling event, better transportation for township resident's, increased community engagement, partnering with SCARCE, and a new township website.

The next order of business was the consideration of the proposed Resolutions.

Paula McGowen of Glen Ellyn moved, seconded by Steve Johnson of Glen Ellyn to approve the resolution entitled, "Fixing Hour for the Township Meeting". The motion passed by voice vote. The resolution is attached and made part of these minutes.

She would like to see more White and Red Oak trees planted around the township. And would like to see SALT be more proactive in helping seniors with changing fire alarm batteries.
