An ordinance levying taxes for all town purposes for Milton Township, DuPage County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Milton Township, DuPage County, Illinois, as follows:

SECTION 1: That the sum(s) of **Two Million Six Hundred Fifty Six Thousand Six Hundred Sixteen and 17/100 + CMHB One Million One Hundred Thirty Three Thousand and 00/100 Dollars (\$2,656,616.17 + \$1,133,000.00 CMHB Tax)** is hereby levied upon all properly subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray ail the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund General Assistance Fund Community & Mental Health Fund

for the fiscal year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:




SECTION 5: That this ordinance shall be in full force and effect after its adoption as provided by law.
