### REAL ID DEADLINE APPROACHING SOON

Beginning May 7, 2025, the Federal Government will require every person 18 years and older to present a REAL ID-compliant state issued driver's license or ID card to board a flight. Another acceptable form of identification, would be a valid U.S. Passport.

You do not need a REAL ID to drive, vote, or identify yourself for general identification purposes. **Secretary of State Alexi Giannoulias has encouraged travelers to "make sure you really need one."** The U.S. Transportation Security Administration has issued a reminder that on May 7th, TSA will no longer accept state-issued identification that are not REAL ID compliant at TSA security checkpoints. As a reminder, if you have a U.S. Passport you are ok!

· Real ID licenses are available at the Lombard, Addison, St. Charles, and Naperville DMV facilities along with a newly expanded facility in Aurora. Some DMV's have extended hours from 7:30 AM to 5 PM on Saturdays. **More information is available at www.ilsos.gov.** 

It should be noted that appointments are required at most facilities. There are specific documents you must bring to the DMV when applying for a REAL ID.

#### These include:

- · A US Birth Certificate or valid Passport
- · A Social Security card or a W-2 showing your nine-digit Social Security number
- · Two documents proving residency issued within the past three months. Those include utility bills, bank statements, and cable or credit card bills

# SCAM REPORT

#### <u>ATM (Automated Teller Machine) Skimming</u>

<u>Introduction:</u> ATM skimming is a type of financial fraud where criminals use concealed devices to steal debit card information and PINs (Personal Identification Numbers). This results in identity theft, stolen funds, and unauthorized purchases. The stolen information is often sold to other fraudsters on the dark web.

<u>How it works:</u> Criminals place fake card readers over the ATM slot to capture information from the card's chip or magnetic strip when the card is inserted. Small cameras or keypad overlays record the PIN. The criminals may return later to the ATM to retrieve the skimming device with the data, or they may access the stolen information remotely using wireless technology such as Bluetooth.

#### Signs of ATM skimming devices

- Misaligned, loose, or bulky card slots.
- Cards that do not slide smoothly and completely into the slot.
- · Keypads that are raised or difficult to press.
- Small holes or attachments near the keypad may indicate the presence of hidden cameras.

#### How to protect yourself

- Use ATMs inside banks or in well-lit public places with security cameras. Avoid using ATMs in remote, dark areas.
- Be cautious when using non-bank ATMs. If an ATM is in a location that does not feel secure, do not use it. Trust your instincts.
- If using an ATM after dark, have an adult accompany you.
- Inspect ATMs for unusual devices or signs of tampering before use.
- · Shield the keypad when entering your PIN to prevent "shoulder surfing."
- Set up transaction alerts with your financial institutions.
- Regularly monitor your financial accounts for unauthorized transactions.

#### Steps to take if you are a victim

- Immediately report the loss to the financial institution that issued the card. The Federal Electronic Fund Transfer Act (EFTA) protects consumers from losses due to unauthorized electronic fund transfers if the losses are reported within 60 days.
- Your financial institution will cancel the card and issue you a new one. Change your PIN to prevent further losses.
- Notify the Illinois Attorney General Senior Citizens Consumer Fraud Helpline (1-800-243-5377 or email seniorhelpline@ilag.gov).
- File a report with your local law enforcement agency.

#### MARCH MEETING PRESENTER

Topic: Abuse Later in Life

Metropolitan Family Shelter Service provides confidential assistance at no charge to adults and children that experience domestic abuse.

Senior adult abuse is an intentional act or failure to act by a caregiver or another person in a relationship involving a experience of trust that causes harm to an older adult (someone 60 +) Domestic abuse can take many forms such as physical, emotional, verbal, sexual and financial.

Stand alone non-profit for over 40+ years, merged with Metropolitan Family Services in 2019. Goal of merger was to provide wrap-around services for clients that we didn't offer: behavioral health, early childhood education, senior services, legal aid etc.

#### PHYSICAL ABUSE

- harming service animals
- using assistive devices against them
- Trapping an older person
- · Physically causing harm
- Tampering with hearing aids, cognitive aids, stair lift, making a brace too tight

#### **EMOTIONAL ABUSE**

- Claiming they are faking being in pain
- · mocking their disability
- Taking advantage of memory loss via gas lighting
- Saying they deserve the abuse for being weak and not contributing to society
- Threatening to initiate nursing home placement
- Prohibiting or limiting access to transportation, communication devices, friends, social events or other resources

#### **FINACIAL ABUSE**

- Illegally unauthorized, or improper use of an older individuals resources for the benefit of someone else
- Forgery
- Misuse or theft of money or possessions
- Using coercion/deception to surrender finances or property
- Improper use of guardianship or power of attorney\
- Conservatorship Abuse
