
Milton Township: WORKING FOR YOU







C.E.R.T. participated in over 70 events and/or trainings this year. The types of events that C.E.R.T. helps with include: assisting with the senior car inspection, various concerts, town festivals, 5k runs, and parades. The team's total volunteer hours resulted in 9,806.11 hours x \$34.79 (volunteer hourly rate) = \$341,154.56. That total is what C.E.R.T. saved the various DuPage County communities.

FOOD PANTRY



The number of food pantry clients served keeps increasing yearly with a year over year increase 2024 to 2025 of 17% to date. This is the result of our partner, the Milton Township Food Pantry charity's commitment to continue to expand partnerships, fundraise, and provide a nutritious and versatile selection.

MTFP is now feeding on average more than 1000 residents monthly. Many thanks to the dedicated volunteers and donors to MTFP, a partner 501(c)3.

Update from Your Milton Township Highway Commissioner: Mike Drew

We are advancing the Highway Department into today's digital age to better serve our unincorporated residents. The website, miltonhighway.org, was recently redesigned to be your go-to source for applicable construction permit applications, reporting a concern, requesting a bond release, and finding resources for block parties, recycling, and brush pick up, plus more!

We are working with go.gov to build a phone app with a web-based location where you, the unincorporated homeowner, can submit complaints or issues with pictures and easily apply for permits. In addition, we have engaged Vialytcs, a company using AI for road management technology. We will have images of all our roads, a detailed analysis of those roads, and a rating using a national rating system for pavement. The program offers an estimating & engineering application to build a five-year plan for repairs & replacement with cost analysis.

If anyone has any questions about the highway department or our rules and regulations, you can call the main office at (630) 682-4270 or Highway Commissioner Mike Drew on his cell phone at (630) 918-3194. With all repair concerns use the website, call the office, or 911. Crews are available 24/7 via the Sheriff's office linking to Highway on call staff.

Update from your Milton Township Assessor: Chris E. LeVan, CIAO

Here's what we do and how we serve you:

- We determine property values for homes, businesses, farms, and other properties in Milton Township.
- We do not set tax rates or decide how much tax is collected-that's the role of schools, local governments, and other taxing bodies.
- We ensure assessments are fair and consistent, so everyone pays only their fair share.
- We review key factors like recent sales, property size, condition, improvements, and--for commercial properties--potential income.
- We maintain accurate property records, updating assessments when properties are built, remodeled, sold, or demolished.

We're here to help! If you have questions about your property value, our office will gladly explain how it was determined and ensure the process is clear and fair.

Important Update - 2025 Assessment Year

- √ We have turned over our 2025 Assessment Rolls to the county.
- ✓ Our County Equalization Factor for 2025 is 1.0846, nearly identical to last year's.
- √ It is one of the lowest factors of all nine DuPage County Townships.
- √ The 30-day window for assessment inquiries is projected to open in October.

Don't Miss your Chance to be Prepared

The truth is, during a catastrophic disaster, your neighborhood will be on its own during the early stages of an event. After such a disaster, citizens will naturally volunteer to help. Unfortunately, these people can expose themselves and others to potential injury and even death without training. Experience has shown that basic training in disaster survival and rescue skills increases citizens' chances of survival until help arrives.

In CERT training, you learn: fire safety and suppression, disaster medical operations, damage assessment, organization, terrorism and disaster psychology, and disaster preparedness. Classes occur every September and March. <u>Learn more at miltontownship.net/cert</u>



Helping our Hungry Neighbors

Milton Township Food Pantry works hard to ensure that no one in need goes hungry. The Milton Township Food Pantry is a partnering 501(c)(3), supported by donations from the community and operated by volunteers. No tax dollars are used for supplies, and all donations are fully tax-deductible as allowed by state law. It is located at the Milton Township Town Hall in donated space: 1492 N. Main Street, Wheaton.

Registration requires sharing a photo ID. Residents are helped in the order they arrive, working one-on-one with a volunteer to move through the pantry. The pantry is open Tuesday-Thursday, 9 a.m. to noon; appointments are also available. Food donations are accepted Monday-Friday, 8:30 a.m.- 4:30 p.m.



THANK YOU FOR THE GARDEN PRODUCE

Healthy, nutritious produce is always a part of Milton Township Food Pantry. The pantry has gotten an extra boost this year from local gardeners. MTFP put out the call for extra tomatoes, zucchini, kale, and garden grown items to add to its regular produce from local grocery stores and Northern Illinois Food Bank. MTFP was delighted by your response!



FY24 TRANSFORMATION PARTNERSHIP GRANT AWARDED BY THE DUPAGE FOUNDATION.

The Milton Township Food Pantry is happy to provide over 2,200 bags of nutritional groceries that include items like milk, eggs, bread, fresh fruits and veggies, and meats monthly. MTFP recently received a FY24 Transformation Partnership Grant from the DuPage Foundation, providing funds for a pallet loader and hand carts. This gift funded important equipment, making the increased volume of donations easier to move and store. DF is transforming MTFP's ability to meet increased demand.



FOOD PANTRY VOLUNTEER SPOTLIGHT

Insight from Trustee Jackie McGrath

After 100 days of serving as a Milton Trustee, I have three insights: first, I am grateful for expert and experienced staff who work so hard on behalf of the Township and are willing to share their knowledge and point of view with me as I learn the ropes. As a new Trustee, I hope I've been able to offer critical questions in a calm, thoughtful, and respectful tone, and I appreciate that my long lists of questions are answered in the same spirit.

Second, it's very meaningful to help solve ongoing challenges in the Township, from updating governance practices and financial processes to studying and planning for increased community needs throughout Milton. I am hopeful that once we clear the decks of some of the problems from the past, I can help contribute to new ideas and initiatives in line with the Township's duties. Last, it is clear there is so much potential for improving general awareness and support throughout Milton Township for the programs and services provided by the Township—in the end, it is a very straightforward unit of government with a clear charge: "the duty of providing relief and support to poor and indigent persons in the territory" (60 ILCS 1/10-20). I will continue to ground my work as a Trustee in that duty, and it guides my vote on every motion. It is an honor to serve in this role, and I know Milton Township is making a meaningful difference for so many people.



MILTON TOWNSHIP GENERAL ASSISTANCE Need Help with Rent, Mortgage, Utilities, Emergencies?

We have an Emergency Assistance program for basic needs for rental assistance and disconnected utilities. Appointments are required and requested documentation must be presented at the time of application. Requests for rental assistance must include a 5-day notice from your landlord for the current month's rent and a copy of your lease. There must be a Final Notice prior to Disconnection on a utility bill in order for the Township to consider it an emergency and the Township cannot assist with gas or electric bills when the LIHEAP program is in effect.

Milton Township can help with heating bills. We are now scheduling in-person appointments for the Low-Income Home Energy Assistance Program that helps income-eligible households pay for home energy services. The LIHEAP program will run from Oct. 1 through Aug 15, 2026, or until funds are exhausted. Beginning on October 1st, residents can apply if someone in the household is 60 years or older, receiving Social Security disability benefits, has a child younger than 6 years old or has either a utility disconnected or has received a disconnection notice. Beginning Nov. 1, all other households who are income eligible can apply for energy services. Adults 55 or older can call (630) 668-1616 to make an appointment.

Neighborhood Roll Call is a community outreach initiative where police officers engage with residents in their neighborhoods to discuss safety, foster relationships, and address concerns. MILTON TOWNSHIP CEMETERY COMMISSION Our Short & Midterm Goals

Cemetery maintenance specifically of historic and pioneer cemeteries is part of Township duties outlined by The State of Illinois. As we mark 175 years in Milton Township, ongoing stewardship of the three local cemeteries where veterans, pioneers and their relatives as well as neighbors who cannot afford burial, remains a priority for the Township.

The Milton Township Cemetery Commission has set near term goals to better steward the three cemeteries it manages. At Jewel Grove Cemetery, a plat of survey was performed in anticipation of upcoming tree maintenance. Tree trimming in this forested grove will be spread over this and future years. At Pleasant Hill Cemetery, a park like cemetery, fencing on the north and west sides as well as an old shed, have been removed to offer access and beautify the area. Spring bulb planting is underway performed by Friends of the Pioneer Cemeteries. Regarding St. Stephen Cemetery and Prairie, the commission is working to create a maintenance plan for the remnant prairie.

The commission is looking for 3-4 additional members, those especially with genealogical research, or prairie and woodland knowledge. Contact Supervisor Higgins-Beard, b.higginsbeard@miltontownship.net.

Refund Phishing Scams

In refund phishing scams, fraudsters pretend to be representatives from well-known companies or government agencies to convince victims they are owed a refund. They use fake communications designed to look legitimate to trick victims into providing sensitive personal information.

<u>How it works:</u> Victims receive calls, emails, or text messages stating they are eligible for refunds due to overpayments for goods, services, or taxes. They are told their personal information is needed to process the refund and instructed to act quickly before the offer expires. Instead of issuing a refund, the scammers steal sensitive information, such as Social Security numbers (SSNs), bank account details, or credit card information.

Victims are often asked to click links or open attachments in emails or text messages to process a refund. These lead to fake websites designed to extract personal information or install malware.

How to protect yourself

- Do not respond to suspicious refund messages, including those in which you are told to act quickly before the offer expires.
- Do not open attachments or click links in unsolicited messages.
- If you believe a refund message is legitimate, contact the sender for verification. Use trusted contact information, not information provided in the message.
- Look for messages with poor grammar and spelling errors, as these are signs of scams originating in other countries.
- Be wary of generic greetings such as "Dear Customer" instead of your actual name.
- Do not be fooled by Al-generated voices that are used to make telephone scams sound convincing.
- Never grant remote access to your device to anyone claiming they need it to process a refund.
- Be cautious of spoofed calls. Your caller ID may have been manipulated to confirm the caller's identity.
- When offered, enable multi-factor authentication (MFA) for your online financial accounts to add an extra layer of protection.
- Use strong, unique passwords for your online financial accounts. Consider using a password manager.
- Be sure your device is protected with reliable antivirus and anti-malware software.
- Keep the operating system and web browser on your device up-to-date
- Regularly monitor your financial accounts for suspicious activity.
- Be wary of scam recovery offers. Scam victims are often exploited a second time by fraudsters who offer to recoup their losses in exchange for personal information or an upfront fee.

Notify the following agencies if you are a victim:

APRIL S.A.L.T. TALK: UNCLAIMED ASSETS ILLINOIS STATE TREASURER'S OFFICE OVERVIEWS ICASH PROGRAM

Marty McCormack, spoke about the ICASH program at SALT's April meeting. **Here's what we learned:**

- There is currently \$5 billion in recovered cash belonging to millions of Illinois residents that is waiting to be claimed at the Illinois Treasurer's Office!
- One in four Illinois adults discovers property to claim when they search.
- Assets can be held in safe deposit boxes of banks that have closed or life insurance policies that have unclaimed money for which an individual was named as the beneficiary.
- You can check the <u>Illinois Treasurer.gov/ICASH</u> website to see if you have unclaimed property in Illinois.
- To check unclaimed assets in other states, visit missingmoney.com, the official Unclaimed Property website of the National Association of State Treasurers.

DUPAGE RECORDER OF DEEDS OFFICE STANDS READY TO ALERT YOU TO MORTGAGE FRAUD



Property Fraud Alert allows you to have your name monitored within the Recorder's office to track possible fraudulent recordings that affect your property. Sign up at: propertyfraudalert.com/ILDupage.

This service does not prevent fraud from happening. However, it provides an early warning system for property owners to take appropriate actions if possible fraudulent activity has taken place.

- The Ombudsman program ensures that older persons and persons with disabilities receive quality services and a dignified life at the highest practical level
- The Ombudsman advocates for residents of long-term care facilities
- The Ombudsman Program is resident-directed

Residents Have the Right To:

- · Safety and good care
- Participate in their own care
- Privacy
- Manage their own money
- Safety of their personal belongings and property
- Appeal an involuntary discharge
- Participate in social and community activities

- Vote
- Participate in resident councils
- Meet with the Long-Term Care Ombudsman
- Present grievances and receive a prompt response from the facility
- Remain free from threats, punishment, or retaliation.




