President Hartnett called the meeting to order. Secretary Evans completed the roll call.

President Hartnett led the pledge of Allegiance.

Approval of minutes of July 29 ,2025 meeting. Motion to approve the minutes by Member Richman and seconded by Member McCarthy. McGrath abstain as she was not at the meeting.

Funding Partner presentations:

DuPage Health Department. Finally, the Crisis Community Center opening soon. Data collection/reporting is a roadblock. DuPage County Health Department Community Center offers outpatient treatment, residential treatment and partial hospitalization/day treatment and is categorized as an inpatient and outpatient facility. Included in the treatment are couples/family therapy, psychotropic medication and group therapy. Additionally, Dupage county Health Department community Center offers treatment to clients referred from the court/judicial system, people requiring dual diagnosis treatment and children/adolescents with serious emotional disturbance.

Glen Ellyn Youth and Family Counseling. Six-month update is between January – June 202 Milton Township residents have been served. They are on track to utilize all funds given. Their mission is to promote the mental health and well-being of youth, families and the larger Glen Ellyn community. They are available to the Glen Ellyn public schools for case consultation and support. Strong linkages with local schools are imperative for GEYFCS. Their staff advocate for youth and their families who present with unmet critical needs by providing linkage information and assistance to local resources. In some instances, staff will recommend and refer to outside resources.

Their roadblocks are increasing in need at schools and increase in referrals. Hired third clinical counselor to help with numbers.

Old Business: Wheaton library is happy with what is going on for this new Social Worker program. Planning a meeting in November for a fall start and to be on site. Interns placed at each library.

The six-month reports of funding partners have been postponed. Messages were sent for the board to get a better understanding. Health Department maybe send them payment monthly. NAMI sent a unclear message. B.R. Ryall have not answered back. Case, O'Donnell will follow up with them.

The 2026 application review has thirty applications. August, September, October to review. October final decisions will be made.

One application has been submitted for the vacant Board Member spot. A zoom meeting to be had with President Hartnett and Secretary Evans.

July financial reviewed. Member Platt made a motion to approve the financial report. Seconded by Secretary Evans. All were in favor. Motion passed.


