Resolution NO.- 2025-R-15

A RESOLUTION AUTHORIZING MILTON TOWNSHIP TO PARTNER WITH PHARMACIES TO PROVIDE ON-SITE VACCINATION SERVICES, INCLUDING VACCINE EVALUATION, SCHEDULING, AND ADMINISTRATION

WHEREAS, Milton Township (“Township”) is an Illinois Township existing and operating pursuant to the Illinois Township Code, 60 ILCS 1/1-1 *et seq.*; and

WHEREAS, the Trustees of the Township (hereinafter “Town Board”) constitute the governing authority for the Township and possess full power and authority to approve and pass all ordinances, resolutions, rules and regulations necessary for carrying into effect the objects for which the Township was formed, in accordance with the Illinois Township Code; and

WHEREAS, the Illinois General Assembly, through the Township Code (60 ILCS 1/85-13), has specifically authorized townships to provide health-related and healthcare services for their residents; and

WHEREAS, the Township is committed to promoting public health and the welfare of its residents; and

WHEREAS, the Township provides financial assistance, referrals, and other supportive programs to aid the health and safety of the local community; and

WHEREAS, the Town Board supports access to lifesaving vaccinations for COVID, influenza and an ongoing focus in the Township to promote vaccination access for residents; and

WHEREAS, vaccines are an effective means of preventing life-threatening illnesses by boosting the body’s natural immune response to diseases caused by viruses and bacteria. Vaccine programs throughout the world have led to improved overall health of our population by reducing the transmission of disease, permanent and temporary disability, and infant mortality; and

WHEREAS, local pharmacy, Jewel Osco, offers a program at no cost to operate it to the Township, to provide a pharmacy technician and pharmacist to evaluate vaccinations needed, coordinate and schedule appointments with residents and staff, and administer on-site vaccinations at designated times at the Milton Township Town Hall (hereinafter “Vaccination Program”); and

WHEREAS, Jewel Osco and future vaccine service partners offer the Vaccination Programs via insurance coverage for free and, as applicable, with those public residents who are uninsured and underinsured Milton Township covering costs to the residents to a maximum imposed by Milton Township of \$3000 in costs for the two day clinic total; vaccinations are being offered to Milton Township at a discount rate for the uninsured and underinsured with shots averaging \$47-\$361 each depending on shot type; and

WHEREAS, the Town Board finds that offering a Vaccination Program through Jewel Osco or future vaccine service partners, is in the best interests of the health and welfare of Township residents.

NOW THEREFORE BE IT RESOLVED, by the Supervisor and Board of Trustees of Milton Township, DuPage County, Illinois as follows:

SECTION 1: That the above recitals and legislative findings contained in the preamble to this Resolution are true and correct and are hereby incorporated into this Resolution as if fully set forth herein.

SECTION 2: That the Township Supervisor is hereby authorized to work with Jewel Osco Pharmacy or future vaccine service providers to coordinate and advertise annual vaccination clinic opportunities at the Milton Township Offices at 1492 N. Main Street, Wheaton, Illinois, and to take any additional steps necessary to facilitate the Vaccination Program, including taking all actions and executing any documents necessary or appropriate, subject to legal review and consultation with the Township Attorney, to implement and carry-out the on-site Vaccination Program.

SECTION 3: That Township staff and the Township Attorney are hereby authorized to take all actions necessary to support the implementation of the on-site Vaccination Program, including assisting with resident communications, appointment scheduling, on-site logistics, and any other tasks reasonably required to ensure the safe and effective operation of the vaccination clinics, all under the direction of the Township Supervisor.

SECTION 4: If any section, paragraph, clause, or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

SECTION 5: All ordinances, resolutions, motions, or orders in conflict with this Resolution are hereby repealed, to the extent they are inconsistent with this Resolution.


SECTION 6: This Resolution shall be in full force and effect upon its passage and approval.
